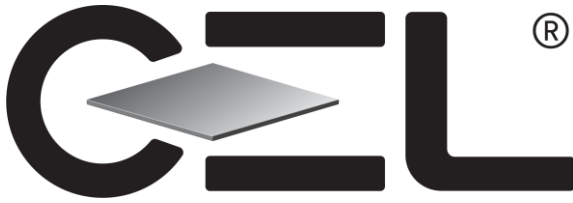
### **Recipients of the data**
